95 Commander Judi Samborski proceeded to open the meeting at 18:57 HRS

Post 95 Commander Judi Samborski led Post in salute to colors.

Post 95 Chaplain Paul Ellison gave the opening prayer.

Post 95 Commander Judi Samborski led the post in the pledge of allegiance and reading of the preamble.

Post 95 Commander Judi Samborski asked Post 95 Adjutant Robert Emery to read the minutes from the October Meeting. Jerry Pate made a motion to forgo the reading of the minutes and proceed with Post business. Jerry Head seconded the motion. The motion passed.

Guest and New Members:

Post 95 Commander Judi Samborski asked if there were any guest or new members present. None were found to be present.

Post 95 Commander Judi Samborski asked for committee reports.

Finance Report:

Post 95 Finance Officer Don Happy apologized to the Post for being slow in his Post 95 duties due to personal reasons.

Post 95 Finance Officer Don Happy reported that he would be getting married in September.

Post 95 Finance Officer Don Happy gave the Finance Report for November through December.

Post 95 Finance Officer Don Happy talked about the Post 95 Building Fund CD which had matured in December. Post 95 Finance Officer Don Happy reported that the Building fund CD had earned fourteen dollars and thirty three cents (\$14.33). Post 95 Finance Officer Don Happy also reported that the ten percent of Post 95 income for the previous year came to seven hundred fourteen dollars and sixteen cents (\$714.16). Post 95 Finance Officer Don Happy said that these funds were added to the monies from the matured Post 95 Building Fund CD for a total of four thousand five hundred ninety seven dollars and twenty three cents (\$4597.23) were deposited into a new nineteen (19) month CD at point sixty five percent interest (.65%) interest rate and would mature August 16th 2015.

Post 95 Finance Officer Don Happy read a letter from Excelsior Bank about a bequest from the estate of James P Stewart in the amount of five thousand dollars (\$5000.00).

Post 95 Finance Officer Don Happy reported he had returned the W-9 form with the requested information.



Paul Ellison remembered sending James P Stewart a fifty (50) year membership certificate.

Post 95 Finance Officer Don Happy said that he was expecting a shipment from emblem sales soon.

Post 95 Commander Judi Samborski talked about new Post member Stephanie Ebner wanted to become active with the Post 95 Honor Team.

Jerry Pate made a motion to take some of the money donated by James P Stewart and purchase a stove for Our Lady of Mercy Country Home. After some discussion the motion was tabled until the Post actually received the funds.

New Members:

Post 95 Vice Commander LeRoy Coe reported no new members.

Membership:

Post 95 Adjutant Robert Emery reported that Department of Missouri had current paid up Post 95 membership as two hundred sixty one (261) and the Post 95 membership goal was three hundred (300) members. Post 95 Adjutant Robert Emery reported that Post 95 had a surplus with Department of Missouri that would pay for twenty seven (27) memberships.

A member asked how come he received his membership dues check back and if the Adjutant sent out a receipt showing dues paid. Post 95 Adjutant Robert Emery said that he had missed the members original dues paid notice and when member asked about paid up dues it was found that he had paid his dues in July and then Post 95 Adjutant Robert Emery issued the member his membership card and returned his second dues check.
