unit behind enemy lines during the Vietnam War, insisting it was real, that he was there, and lived through it. But before and after Robert Levy spoke in a federal courthouse in Camden on 25 JUL, U.S. District Judge Jerome Simandle cited evidence from prosecutors and Department of Veterans Affairs officials that it couldn't have happened, that Levy was making up important parts of it. Known as the "Missing Mayor" because he dropped out of sight for two weeks last fall, he admitted that he had lied about his Vietnam War service, embellishing it to include dangerous exploits with elite special operations forces in order to fatten his veterans' benefits check. The judge let Levy off without a prison term, although the disgraced former mayor will have to repay the \$25,198 he wrongly got from the government, plus a \$5,000 fine, and serve three years' probation. Levy stepped down as mayor in

Levy stepped down as mayor in October, after admitting his two-week absence was to attend a clinic for treatment of substance-abuse and mental-health issues. During yesterday's hearing, Simandle said Levy unquestionably suffers from post-

The judge said Levy continues to exaggerate his military service, specifically by saying he did work for an elite pathfinder unit, which set up landing zones during the war and made other combat preparations in enemycontrolled territory. Levy insisted he had done several missions with the unit even though he was not a member of it. But Simandle noted that Veterans Affairs officials interviewed commanders and members of the special unit Levy claimed to have served with, and none remembered him. The judge said afterward that "there's no record and no recollection of his service [with the special unit] other than Mr. Levy's." Yet Levy insisted that he had helped the pathfinder unit from time to time. "Being young. 17 years old, I wanted to help and do whatever I could for my country," Levy said. "I just volunteered and went. There were no orders; I picked up my M-16 and my radio and went along. On occasion, they would ask me, and I said yes. I was 17 young, strong and dumb."

Levy is now unemployed, without an income (the Veterans Benefits Administration has

stripped him of all benefits, including those he had been receiving for physical injuries) and still dealing with mental health issues from the war. Simandle repeatedly praised Levy's service, which included two tours in Vietnam that left him with serious psychological ailments that went untreated for years. The judge said Levy continues having trouble determining what is real and what is not. Jacobs said Levy emerged from the war "with severe psychological wounds." Since leaving the Army in 1984, Levy has grappled with anxiety and depression, Jacobs said. Those problems worsened after the Sept. 11, 2001, terror attacks. The stress of running for and serving as mayor - he falsely claimed in campaign literature to have served with the Green Berets – also took its toll. "He couldn't function as mayor," the judge said. "All the other stuff was catching up to him. What he went through was a crisis. He didn't come out of it well."

Clarification

From John Kopp
Recently there has been some concern about seeing various people at the Democratic and Republican Conventions wearing their official American Legion Covers. So, I wrote a message to the National asking for some explanation and clarification of this matter. Here is the response I

received: John.

The American Legion is nonpartisan and nonpolitical in that The American Legion does not endorse or contribute to political candidates or political parties; however, that does not mean The American Legion is not actively engaged in either the electoral or legislative process.

The American Legion's presence at both the Democratic and Republican National Conventions were as guests and observers of the official proceedings. The American Legion presented testimony to both convention platform committees. This testimony is identical and based on resolutions adopted by its National Executive Committee.

Those selected by The American Legion National Commander to attend these

national conventions do not wear political party badges, except for official credentials issued by the party to grant entrance and access to their national convention. They are not authorized to endorse any political candidate or party; however, are authorized to address official positions of The American Legion with convention delegates or the media covering the national convention.

All other Legionnaires attending political events as delegates, guests, or participants may wear The American Legion service cap; however, are not authorized to endorse any political candidate or party on behalf of The American Legion - but rather as a private citizen. For example, an American Legion color guard can post or retrieve colors as a part of the official convention program; a Legionnaire may lead the delegates and guests in reciting the Pledge; a Legionnaire could offer the invocation or benediction; or be a delegate or alternate; however, all should refrain from wearing any political buttons or pins on The American Legion service cap.

It is, however, permissible to render proper courtesy to guest speakers and elected officials. It

is also permissible to show support for official positions of The American Legion.

The American Legion's "Get Out The Vote" is a national program that encourages voter registration, voter education, and voter participation. This program encourages nonpartisan voter registration efforts within local communities, to include at high schools, veterans homes, and even at American Legion post homes. Voter education promotes hosting nonpartisan veterans' town hall meeting and "Meet the Candidates Nights" by American Legion Posts. Voter participation encourages nonpartisan assistance with absentee voting and transporting voters to the polls. Wearing The American Legion service cap while voting can also a nonpartisan activity.

Many elected officials and candidates are Legionnaires and wear their American Legion service caps to special events and speaking engagements; however, they too must comply with the nonpartisan aspects of being a Legionnaire.
