concussions being eligible for the medal. Official Army guidelines have long considered combatsustained concussions a valid injury worthy of the Purple Heart, but in practice, it has been left to doctors or battlefield commanders to decide whether a blow to the head during combat warranted the medal. With recent studies on brain trauma, however, the rules have been revised to state what constitutes a concussion, with symptoms including momentary loss of consciousness or memory, dizziness, headache, nausea or light sensitivity. Medical treatment, also required for the medal, is defined by the rules to include merely rest and Tylenol. If you are a Soldier who suffered a concussion and feel you may not have been appropriately recognized for a Purple Heart, the Army urges you to re-apply through your chain of command. 

POW-MIA Recognition Day

The Paris Peace Accords of January 27, 1973 was the agreement thirty eight years ago to end the war and restore peace in Vietnam. The U.S. pledged to cease hostilities (ground, air, naval, and to deactivate mines in all waterways) with total withdrawal to be completed in 60 days. All parties committed to no further acts of force on the ground, in the air, and on the sea. This prohibition also included terrorism and reprisals. Both Vietnamese sides were permitted to replace arms and war materials destroyed, damaged, or worn out. under supervision of the Joint Military Commission. Also agreed to was the return of all captured military personnel and foreign civilians within a 60-day period. North and South Vietnam were to begin peaceful negotiations on establishing normal relations and reunification. And so it ended. At least the war. Not the memories, nor the pain, nor the losses. Again, on the third Friday of

Again, on the third Friday of September – this year it's September 16th – citizens and combat veterans will join together in a nationwide observance of POW-MIA Recognition Day – never to

forget the Prisoners of War or those Missing in Action who sacrificed for their country and didn't return. There will be rallies and 24-hour vigils and the reading of names, and candlelight ceremonies. Some groups will have a Missing Man Honors Ceremony with a lone round POW-MIA table, covered by a white cloth topped with an inverted water glass, a lemon slice on a bread plate, a lit candle, and an empty chair indicating that a diner is missing. Or there may be five or six place settings and empty chairs - one for each of the five branches of service, plus civilians. According to the National League of POW-MIA Families, the round table represents everlasting concern; the white tablecloth, the purity of their motives when answering the call of duty; a single red rose, a reminder of the lives of these men, their relatives and friends; the red ribbon, the determination to find them; a slice of lemon, the bitter fate endured by those captured and missing in a foreign land; a pinch of salt, the tears shed; a Bible, for strength through faith; the inverted glass, the inability to share the evening's toast; and empty chairs because they are missing. finally, a toast to honor
America's POW-MIAs and to the success of efforts to account for them.

A black and white POW-MIA flag will fly below the U.S. flag at federal facilities and cemeteries, post offices and military installations, state capitols, schools, and ships at sea, VA medical facilities, the World War II Memorial, Korean War Veterans Memorial, the Vietnam Veterans Memorial, the official offices of the secretaries of state, defense and veterans affairs, the director of the selective service system, and the White House. This observance is one of six days throughout the year that Congress has mandated the flying of the POW-MIA flag. The others are Armed Forces Day, Memorial Day, Flag Day, Independence Day, and Veterans Day.

POW-MIA Flag

In 1970, Mary Hoff, an MIA wife and member of the National League of American Prisoners and Missing in Southeast Asia recognized the need for a symbol for our POW-MIAs. The job fell to graphic designer Newt Heisley to design a flag to represent the group just as Heisley's son was returning from Marine training at

Quantico. Home after becoming ill during training, Jeffrey's gaunt appearance became the inspiration for the silhouette. Newt Heisley, himself a World War II veteran who flew missions in the Pacific, was glad he got the chance to design the symbol. "I used to fly within range of the Japanese and wondered how I would hold up if I ever got captured. When I did the design, I thought how easy it would be to forget those guys," he said. "You are not forgotten"

The now familiar slogan, "You are not forgotten," was born of that sentiment. Heisley also remarked in an interview that the flag was not originally intended to be black and white. He figured that once the League selected the design from the several he submitted, a suitable color would be chosen — one less somber, more optimistic. Obviously, the black and white motif was the one preferred.

The image was never copyrighted and is now part of the public domain. Neither Heisley nor the League ever anticipated the flag's popularity would reach the level that it has today. Newt Heisley has been honored by Congress and by many veterans groups and

patriotic organizations in the years since he first conceived the flag design.

Congress passed a resolution on July 18, 1979 authorizing POW-MIA Recognition Day. On March 9, 1989, an official League flag was installed in the US Capitol Rotunda where it stands as a powerful symbol of national commitment to America's POW-MIAs. It is the only flag ever to be honored in this way. On August 10, 1990, Congress officially recognized the League's POW-MIA flag. In 1998 it was required that the POW-MIA flag be flown from military installations, national cemeteries, VA medical centers and many other federal buildings.

coastline from 1962 to 1975. The designated vessels either entered the country's inland waterways, docked in Vietnam, or their sailors went ashore, possibly exposing them to the widely used herbicide.

Many of the new ships are landing vessels or destroyers that operated near the shore. The large escort carrier Kula Gulf also was added because it served as a helicopter and troop transport in Cam Ranh Bay for three days in November 1965.

Flag Amendment

Washington, DC (June 14, 2011) – Senators Orrin Hatch, R-Utah, and Max Baucus, D-Mont., introduced a constitutional amendment today that would return to the American people the right to protect their flag. The one sentence amendment, Senate Joint Resolution 19, reads, "The Congress shall have power to prohibit the physical desecration of the flag of the United States.

The measure enjoys wide support among the American public and the U.S. Congress. It has previously passed the House of Representatives six times, but fell only one vote shy of the two-thirds required in the Senate. A companion bill, House Joint Resolution 13, has been introduced in the House.

"The process for amending the Constitution — set forth in Article V — is part of the Constitution," said Richard Parker, Harvard Law School's Williams Professor of Law and Chairman of the Board of the Citizens Flag Alliance. "Indeed, it is its lynchpin. For it fastens the ongoing authority of the Constitution to its foundation in popular sovereignty."

The struggle to protect the flag from desecration was ignited

shortly after the U.S. Supreme Court ruled in 1989 that flag desecration was "protected speech." The 5-4 Texas v. Johnson decision invalidated flag protection laws in 48 states and the District of Columbia.

To date, 50 states have passed memorializing resolutions asking Congress to pass the amendment and send it to the states for ratification.

"The Citizens Flag Alliance was formed in 1994 to restore to Congress the power - which it had for the first 200 years in our history - to defend the American flag when misguided individual's burn it or urinate on it or subject it to other kinds of physical desecration," Parker continued. "Many amendments over the last two centuries were adopted after campaigns longer - some a lot longer - than ours. Encouraged by the progress we have made, by the conviction in the rightness of our cause, and by the longstanding support of the American people, we will continue to persist - and expect to win."

Suddenly, there was a lone voice from the front of the auditorium, then a dozen voices, and soon the room was filled with the voices of a thousand soldiers, finishing where the recording left off: "And the rockets' red glare, the bombs bursting in air, gave proof through the night that our flag was still there. Oh, say, does that Star Spangled Banner yet wave, o'er the land of the free, and the home of the brave."

It was the most inspiring moment I have had in Iraq, and I wanted you to know what kind of U.S. Soldiers are serving you! Remember them as they fight for us!

Pass this along as a reminder to others to be ever in prayer for all our soldiers serving us here at home and abroad. Many have already paid the ultimate price.
