Post 95 Finance Officer Don Happy reported total income for the Chili Supper was nine hundred thirty (\$930.00) dollars with a total cost of two hundred ninety eight dollars and twenty one cents (\$298.21).

Post 95 Finance Officer Don Happy reported that a Post member had donated money for the purchase of hamburger for the chili. Post 95 Finance Officer Don Happy reported a total surplus for the Chili supper of seven hundred eleven dollars and sixty one cents (\$711.61). Post 95 Finance Officer Don Happy reported that the ten percent (10%) to be paid to the VFW would be seventy one dollars and eighteen cents (\$71.18) making a total



final profit for the Chili Supper of six hundred forty dollars and sixty one cents (\$640.61).

Post 95 Finance Officer Don Happy reported that the income from the raffle was seven hundred twenty dollars (\$720.00) with a total cost for the raffle prizes being three hundred dollars (\$300.00) leaving a total profit for the raffle of four hundred twenty dollars (\$420.00). Post 95 Finance Officer Don Happy reported the total surplus from the event was sixteen hundred dollars and sixty one cents (\$1600.21).

Post 95 Finance Officer Don Happy talked about getting food handler certification for Post members before the next fundraising dinner since everyone's certification had expired.

Post 95 Finance Officer Don Happy thanked all those who had helped make the Chili Supper a success.

Membership:

Post 95 Vice-Commander LeRoy Coe reported that Post 95 paid up membership was currently at two hundred thirty five (235) members making the Post seventy eight point six percent (78.6%) and that the Post 95 membership goal is two hundred ninety nine (299) members.
